JEFFREY MERRITT aka Jeff, formerly incarcerated in Missouri State Penitentiary from June, 1962, to August, 1964 and from November, 1965, to December, 1967, interviewed by New York. MERRITT recalled subject RAY as being one of the inmates at the Penitentiary and said he and RAY had worked together on the loading docks there. He stated his knowledge of RAY was limited and he could not recall anything specific regarding his background, habits or description, which would be of value in locating RAY. He pointed out that RAY appeared to be a "loner" and associated very little with other inmates. Due to the policy of segregating white and Negro inmates in their living quarters, MERRITT was limited with contacts with RAY.

Following RAY'S escape from the Penitentiary, MERRITT could not recall having heard any comments among the prisoners as to where RAY might have gone.

MERRITT currently resides at 346 West 17th St., NYC, telephone 989-3100, and is employed as a mail handler at the National Maritime Union, 36 Seventh Avenue, NYC.

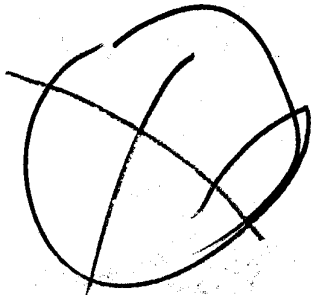



The following investigation was conducted by SAA ROY L. ARNOLD, JR., on April 19, 1968:

WILLIAM PERRY, Assistant to the President, National Maritime Union (NMU), 36 Seventh Avenue, New York, New York, advised that an NMU employee named JEFF MERRITT, aka Jeffrey Merritt, had advised him that he had served time with JAMES EARL RAY in the Missouri State Penitentiary. PERRY advised that MERRITT is presently on parole and officials of the NMU have given him a job and are doing everything possible to assure that MERRITT does not violate his parole. In connection with his parole, PERRY believed that it would be beneficial for MERRITT to go on record as having cooperated with the Government by telling anything he knew about RAY. PERRY advised that MERRITT is very sensitive about his criminal background and requested that MERRITT be advised that the information desired pertained only to his knowledge of RAY. PERRY advised that MERRITT is a promising negro heavy-weight fighter and he had just completed a fight earlier in the evening. PERRY stated that he did not advise MERRITT that he was to be interviewed by the FBI prior to the fight because he believed MERRITT would become upset to the extent that it would affect his chances of winning. PERRY introduced MERRITT and made him available for interview in PERRY's office at the NMU.

JEFFREY MERRITT aka "Jeff", advised that he is presently employed as a mail handler at the NMU, 36 Seventh Avenue, New York, New York, and he resides at 346 West 17th Street, New York, New York (telephone 989-3100). He advised that he is presently on parole from the Missouri State Penitentiary, Jefferson City, Missouri, where he was incarcerated from June, 1962 to August, 1964, and from November, 1965 to December, 1967.

MERRITT identified a photograph of JAMES EARL RAY as one of the inmates at the Missouri State Penitentiary whom he recalled during his incarceration from November, 1965 to

December, 1967. MERRITT recalled that he and RAY had worked together on the loading docks at the penitentiary. MERRITT stated that his knowledge of RAY was limited and he could not recall anything specific regarding RAY's background, acquaintances, habits or description which would be of value in locating him. MERRITT pointed out that RAY appeared to be a "loner" and associated very little with others insofar as he was able to notice. Due to the policy of segregating white and negro inmates in their living quarters, MERRITT was limited in his contacts with RAY.

MERRITT recalled that RAY had escaped from the penitentiary. He advised that this was handled in a routine manner in that the prisoners were held in their cells for a few hours while the grounds and buildings were searched, after which the prison returned to its usual functions. MERRITT did not recall having heard any comment among the prisoners as to where RAY might have gone. MERRITT advised that he would contact the FBI if anything came to his mind which would be of value in locating him.
