SUBJECT: ASSASSINATION OF MARTIN LUTHER KING, JR., RACIAL MATTERS.

At 10:32P.M. date, the writer was furnished the following information from SA Roy Klager, FBI, Kansas City, as relayed from the Bureau, to notify the SAC instant date.

From George Moore of the Racial Intelligence Section, Re Assassination of Martin Luther King.

Instructions are: Take all necessary precautions re personnel proceeding to and from offices tonight, tomorrow, and over the weekend. Be sure personnel are most judicious as to when and where they travel dependent of course on local conditions. Each SAC exercise prudence and issue appropriate instructions under the circumstances. Each SAC must understand that he has responsibility to have adequate manpower on duty to handle any emergency which might arise during critical hours ahead.

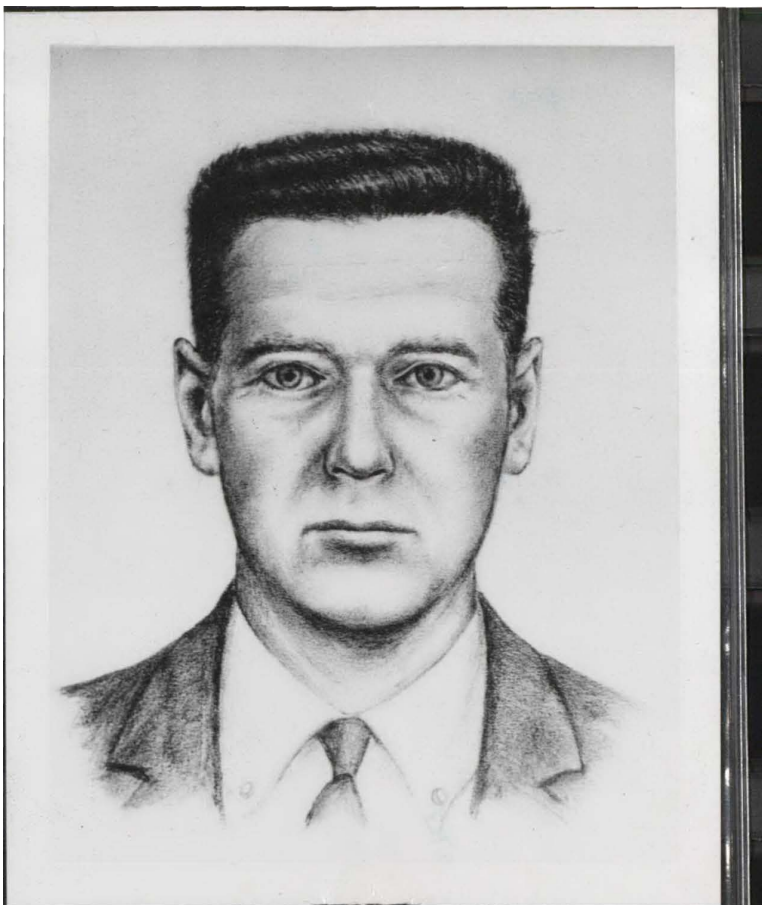
