


Re Memorandum of ALBERT L. PIERCE, 4/20/68.

On 4/23/68, DAVID FRAME, 313 James Road, Carlisle, Pa., an employee of General Motors Acceptance Corporation, Harrisburg, Pa., advised SA ROBERT F. SAVARD, JR., that on Saturday night, 4/19/68, at about 9:30 p.m., he and his wife were at Willows Tavern, Carlisle, Pa., at which time they observed a man who resembled the photograph he had seen that date in the newspaper, the individual being ERIC STARVO GALT. This was the first and only time that FRAME had ever seen this person in the tavern and has not been back to that tavern since that time. He appeared to be in his late 30s, about 6' in height, average build, brown hair, no noticeable scars or marks. He was clean and appeared to be well-dressed in a sport shirt and slacks. Neither FRAME or his wife mentioned the similarity to anyone else in the bar and they have not discussed it with anyone else. The man was by himself and did not appear to carry on any conversation with anyone else.

On 4/26/68, Mrs. LYNETTE A. FRAME, wife of DAVID FRAME, advised SA GEORGE H. KEENAN that she was with her husband on the evening of 4/19/68 at Willows Tavern, Old York Road, Carlisle, Pa. at about 9:30 p.m. when they both noticed a man sitting at the bar who appeared to be very similar in appearance to the right hand photograph of four photos of ERIC STARVO GALT, which appeared in the local papers that day, the photograph being the one in which the eyes were drawn. Neither she nor her husband had ever seen this man in the tavern before. They both attend this tavern on a regular basis and have been in there since that time and have not seen this man again. They did not mention their recognition to anyone else in the bar nor to anyone other than the FBI.

She described the individual as being a white male, 37 - 39 years of age, 5'11", average build, broad shoulders,

brown hair, balding in front and wavy, odd shaped face. being slightly square in appearance, The individual smoked cigarettes, drank beer and ate a pizza while there. He was by himself, did not carry on any conversation with anyone else in the bar including the bartender. He appeared to be clean and was dressed in a blue plaid sport shirt, trousers of an unrecalled color, no coat and no hat. He sat at the bar the whole time and from the way he moved his hands, he seemed to her to be slightly effeminate. She added that apparently no one else in the bar recognized the man as did she and her husband because she has not heard any conversation on this point. She was unable to recall the identity of anyone else in the bar at that time.

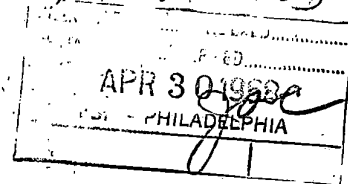

On 4/24/68 Mr. HECTOR SQUILLACIOTTI, Special Service Representative, Veterans Administration Center, 5000 Wissahickon Ave., Philadelphia, Pa., made available National Service Life Insurance (NSLI) policy #N19 868 336 pertaining to JAMES EARL RAY and the following information was obtained:

JAMES EARL RAY made application for a \$10,000 term NSLI policy on 2/21/46 at Fort Sheridan, Ill., listing his date of birth as 3/10/28 at Alton, Ill., and his beneficiary as his mother LUCILLE MARY RAY, 538 E. Broadway, Alton, Ill.

RAY entered on duty in the military service on 2/19/46 under serial number [REDACTED]. His monthly insurance premiums were made to the VA by allotment from his military pay and amounted to \$6.40.

His monthly allotments were discontinued to the VA on 3/31/47 at his own request and his NSLI policy lapsed on 5/21/47.

On 7/25/50 the VA sent RAY a 1948 Special Dividend which amounted to \$82.50. His address at that time was 215 Oak St., Quincy, Ill. This is the last contact the VA had with JAMES EARL RAY and his file has been in a closed status since that time.
