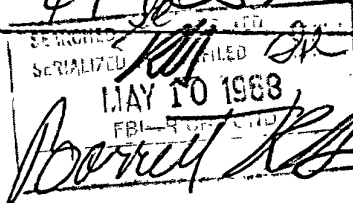

HALL, JR., morning of 4/19/68, to the effect that one DALE GOFF, Night Manager of the Clarendon Hotel Court, 3824 Wilson Blvd., Arlington, Va., had, on 4/17/68, at approximately 7 A. M., observed an individual in the office of this motor court who closely resembled the photograph of ERIC GALT.

SA's ROLAND M. COCKER and JOHN L. LYNCH responded to the Clarendon Motor Hotel Court and contacted Mr. GOFF, who advised that he noticed an individual in his motor court lobby at approximately 7 A. M. on the morning of 4/18/68 by himself and described him as a white male, 5' 10" - 5' 11", dark hair, and well-dressed wearing a light gray suit.

Mr. GOFF mentioned that on the evening of 4/18/68, he observed the FBI photo of GALT appearing in the "Evening Star" newspaper and felt compelled to call this to the attention of the FBI.

Mr. GOFF advised he has no one staying at the motor court by the name of GALT, HARVEY LOWMYER, or JOHN WILLARD, the aliases of GALT. Mr. GOFF, thereafter, made

available to SA's LYNCH and COCKER the registration cards for all residents of the motel for the period of 4/18-19/68. A review of these registration cards reflected no identifiable name with that of the subject, GALT, or his aliases.

There were no registered guests from Memphis or the Atlanta area. Mr. GOFF mentioned that he did not know if this individual was a guest or if he had just stopped in the motel.

A surveillance was thereafter undertaken for the remainder of the morning and the "look-alike" did not reappear in the lounge. Mr. GOFF thereafter made arrangements with his brother, Mr. RAYMOND GOFF, the Day Manager, to immediately contact the Alexandria Resident Agency of the FBI, should the individual be seen or an automobile be observed.

Mr. GOFF reflected that there are 108 units in this motel, and it is impossible to acquaint himself with each of the guests. He stated that he would remain alert and keep the newspaper photograph available at the front desk, should this man reappear.

No further investigation is contemplated at this time in this regard unless additional information is received from the Clarendon Motor Hotel Court.

She stated that she never traveled to the State of Fla. with her cousin, SHELBY JEAN, and, in fact, has never left the State of Va. She also advised that to her knowledge SHELBY JEAN has never traveled to Fla. She stated that SHELBY JEAN has had some difficulty with men and her marriage to ELBERT BALDRIDGE is her second. She further stated that while BALDRIDGE was in Vietnam SHELBY JEAN lived with another man in Texas. She said it is her opinion that SHELBY JEAN is trying to get away from BALDRIDGE. She stated she does not know anyone named ERIC RAY or EARL RAY and never heard SHELBY JEAN mention anyone by that name. She observed photographs of JAMES EARL RAY and advised she has never seen anyone who resembles the photo nor does she know this man. *Index*

She stated that to her knowledge SHELBY JEAN has never traveled to Fla. at any time and she has never heard her mention an ERIC RAY or EARL RAY. She stated her daughter is having some marital difficulties with her husband, ELBERT BALDRIDGE. She said SHELBY JEAN visited her in December, 1967, and left in January, 1968, to return to Texas but she has not heard from her since that time. She said she had no idea of her whereabouts until BALDRIDGE called her about 4/23/68 and told her he received a letter from SHELBY JEAN postmarked Saltville, Va. Mrs. FAUCETT advised she has no people in Saltville, Va., and did not know why her daughter would be in that section of the state. Mrs. FAUCETT further advised that Sgt. BALDRIDGE told her not to worry about SHELBY JEAN because he had the FBI and Red Cross looking for her and they would find her soon. Mrs. FAUCETT observed pictures of JAMES EARL RAY and advised she did not know him nor did she recognize any of the photographs. Mrs. FAUCETT advised that should she learn the whereabouts of her daughter, SHELBY JEAN, she would advise this office.

On 5/2/68, an individual giving his name as PAUL MINNICK, Prince George County, Va., telephonically contacted the Petersburg RA wherein he advised that an individual by the name of WILLIAM WALLACE, who lives at 601 Reservoir Ave., Petersburg, Va., was the individual who did the "good job" on MARTIN LUTHER KING. The caller made numerous anti-Negro remarks and then hung up the phone on the Agent who was conversing with him.

A check of the indices at Richmond Headquarters reflected negative information with regard to WALLACE.

On the evening of 5/2/68, Rev. CURTIS HARRIS, State Director, Southern Christian Leadership Conference (SCLC), telephonically contacted Richmond Headquarters and advised he desired to speak to an Agent. The writer telephonically contacted HARRIS, wherein HARRIS advised that between 7:15 and 7:30 P.M. on 5/2/68, he received two telephone calls from an individual who would not give his identity. The individual, who appeared to be a white male, according to HARRIS, made numerous anti-FBI remarks and commented that if he (HARRIS) was interested in finding out who killed MARTIN LUTHER KING, he had better check-out a WILLIAM WALLACE, 601 Reservoir Ave., Petersburg, Va. HARRIS advised he did not have any information as to who the unknown caller could be.

In view of the above, the following investigation was conducted on 5/2/68 by SA's GORDON G. ROBKE and RAYMOND CONNOLLY, JR.:

LOIS VAUGHN, 600 Reservoir Ave., Petersburg, Va., was interviewed and she advised that a WILLIAM WALLACE and his wife have resided at 601 Reservoir Ave. for about a year. She further stated that the WALLACES have been in the neighborhood in the last three or four months. She described WALLACE as a white male, about 25 years of age, 5' 10", blond hair.

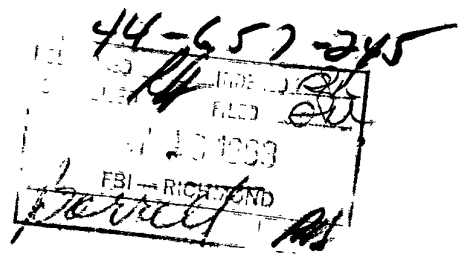

Miss MILLER saw a poster with photographs of JAMES EARL RAY and noted a resemblance of the 1960 photograph to a man with whom she had the following dealings:

Miss MILLER put an ad in the Classified Sections of the Sunday Star and Washington Post advertising a sofa for sale for \$175.00. She believed that the ad appeared in the April 7 or 14th issues. On a Wednesday night after the ad appeared she received a telephone call from a man asking about the sofa. It was late, 11:30 p.m., and the man said he would come to see the sofa the next evening.

He came to Miss MILLER's residence in a station wagon with a male companion and bought the sofa. He paid for the sofa with a check drawn on the Suburban Trust Company, Hyattsville, Maryland. The names DAVID and LALAH COOPERMAN, Account # 67 1940 3 was printed on the check, but no address was listed. The purchaser of the sofa wrote the following addresses and telephone number on the check and signed it "DAVID COOPERMAN".

She did not know the make of station wagon, thought it was late model, license number unknown, light colored with wood tone trim. The companion of the purchaser is described as early twenties, "cute, slim, blonde". No names were exchanged between the two men.

In connection with the captioned case there has been speculation that James Earl Ray concocted the alias of Eric Starvo Galt by combining the names of characters from books by Ian Fleming and from a book "Atlas Shrugged" by Ayn Rand. This speculation is based on the fact that in the James Bond books by Ian Fleming there is a character named Ernst Stavro Blofield and in "Atlas Shrugged" there is a character named John Galt, as well as one named Eric Starnes. Ernst Stavro Blofield is a formidable person, John Galt is a "social drop out" and Eric Starnes is described in the book as a "whiner" from a low-class family.

In view of the above and in order that Agents handling this investigation can be alert to the possibility of Ray's utilizing an alias based on characters in Fleming's books, there is set out as an attachment to this airtel a list of various characters in those books for your assistance.

BALDRIDGE SUBSEQUENTLY QUESTIONED HER MORE THOROUGHLY RE THIS, AT WHICH TIME WIFE SAID THAT, AFTER GRADUATING FROM HIGH SCHOOL IN NINETEEN FIFTYSEVEN, SHE AND HER COUSIN PATSY MADE TRIP TO ^{TAMPA,} FLORIDA, WHERE SHE MET ONE ERIC RAY, WHOM SHE CALLED EARL. WIFE CLAIMED EARL MUCH OLDER THAN SHE. WIFE NOT KNOWN TO HAVE EVER CORRESPONDED WITH EARL. BALDRIDGE WONDERED IF WIFE WAS POSSIBLY IN CONTACT WITH SUBJECT JAMES EARL RAY, POSSIBLY IDENTICAL WITH ERIC RAY SHE MET IN FLORIDA.

RICHMOND OFFICE SUBSEQUENTLY IDENTIFIED PATSY AS PATSY OWEN AND INTERVIEWED HER AND MRS. LENA FAUCETT, MOTHER OF SHELBY JEAN, AT CLARKSVILLE, VIRGINIA. BOTH DENIED ANY KNOWLEDGE OF ALLEGED TRIP TO TAMPA BY PATSY AND SHELBY JEAN. BOTH DISCLAIMED ANY KNOWLEDGE OF ERIC RAY, AKA EARL. RICHMOND WAS UNABLE TO LOCATE SHELBY JEAN FOR INTERVIEW IN SALTVILLE, VIRGINIA, AREA.

SGT. BALDRIDGE SUBSEQUENTLY STATED HE NEVER DISCUSSED TAMPA TRIP WITH ANYONE BUT WIFE AND DIDN'T KNOW IF ANY TRUTH TO IT. SHELBY JEAN NEVER SAID ANYTHING TO HIM TO INDICATE SHE HAD EVER CORRESPONDED WITH OR MAINTAINED CONTACT WITH ERIC RAY, AKA EARL.
