HALL, JR., morning of 4/19/68, to the effect that one DALE GOFF, Night Manager of the Clarendon Hotel Court, 3824 Wilson Blvd., Arlington, Va., had, on 4/17/68, at approximately 7 A. N., observed an individual in the effice of this motor court who closely rescribled the photograph of ERIC GALT.

SA's ROLAND M. COCKER and JOHN L. LYNCH responded to the Clarendon Motor Hotel Court and contacted Mr. SOFF, who advised that he noticed an individual in his motor court lobby at approximately 7 A. H. on the morning of 4/18/68 by himself and described him as a white male, 5' 10" - 5' 11", dark hair, and well-dressed wearing a light gray suit.

Mr. GOFF contioned that on the evening of 4/18/68, he observed the FBI photo of GALT appearing in the "Evening Star" newspaper and felt compelled to call this to the attention of the FBI.

Mr. GOFF advised he has no one staying at the motor court by the name of GALT, HARVEY LONMYER, or JOHN WILLARD, the nlieses of GALT. Mr. GOFF, thereafter, made

available to EA's LYNCH and COCKER the registration cards for all residents of the motel for the period of 4/18-19/68. A review of these registration cards reflected no identifiable name with that of the subject, GALT, or his allases.

There were no registered guests from Memphis or the Atlanta area. Mr. GOFF mentioned that he did not know if this individual was a guest or if he had just stopped in the motel.

A surveillance was thereafter undertaken for the remainder of the morning and the "look-alike" did not reappear in the lounge. Mr. GOFF thereafter made arrangements with his brother, Mr. RAYMOND GOFF, the Day Manager, to immediately contact the Alexandria Resident Agency of the FBI, should the individual be seen or an automobile be observed.

Mr. GOFF reflected that there are 108 units in this motel, and it is impossible to acquaint himself with each of the guests. He stated that he would remain alert and keep the newspaper photograph available at the front desk, should this man reappear.

No further investigation is contemplated at this time in this regard unless additional information is received from the Clarendon Motor Hotel Court.

The following investigation was conducted by SA EUGENE A. FOX:

On 4/26/68, PATSY OWEN, P. O. Box 641, Clarksville, Va., advised she is a cousin to SHELBY JEAN BALDRIDGE, nee Faucett. She stated that she never traveled to the State of Fla. with her cousin, SHELBY JEAN, and, in fact, has never left the State of Va. She also advised that to her knowledge SHELBY JEAN has never traveled to Fla. She stated that SHELBY JEAN has had some difficulty with men and her marriage to ELBERT BALDRIDGE is her second. She further stated that while BALDRIDGE was in Vietnam SHELBY JEAN lived with another man in Texas. She said it is her opinion that SHELBY JEAN is trying to get away from BALDRIDGE. She stated she does not know anyone named ERIC RAY or EARL RAY and never heard SHELBY JEAN mention anyone by that name. She observed photographs of JAMES EARL RAY and advised she has never seen anyone who resembles the photo nor does she know this man.

On 4/26/68, Mrs. LENA FAUCETT, Rt. 1, P. O. Box 240, Clarksville, Va., advised SHELBY JEAN BALDRIDGE is her daughter. She stated that to her knowledge SHELBY JEAN has never traveled to Fla. at any time and she has never heard her mention an ERIC RAY or EARL RAY. She stated her daughter is having some marital difficulties with her husband, ELBERT BALDRIDGE. She said SHELBY JEAN visited her in December, 1967, and left in January, 1968, to return to Texas but she has not heard from her since that time. She said she had no idea of her whereabouts until BALDRIDGE called her about 4/23/68 and told her he received a letter from SHELBY JEAN postmarked Saltville, Va. Mrs. FAUCETT advised she has no people in Saltville, Va., and did not know why her daughter would be in that section of the state. Mrs. FAUCETT further advised that Sgt. BALDRIDGE told her not to wrry about SHELBY JEAN because he had the FBI and Red Cross looking for her and they would find her soon. Mrs. FAUCETT observed pictures of JAMES EARL RAY and advised she did not know him nor did she recognize any of the photographs. Mrs. FAUCETT advised that should she learn the whereabouts of her daughter, SHELBY JEM, she would advise this office.

The caller made numerous anti-Negro remarks and then hung up the phone on the Agent who was conversing with him.

A check of the indices at Richmond Headquarters reflected negative information with regard to WALLACE.

On the evening of 5/2/68, Rev. CURTIS HARRIS, State Director, Southern Christian Leadership Conference (SCLC), telephonically contacted Richmond Headquarters and advised he desired to speak to an Agent. The writer telephonically contacted HARRIS, wherein HARRIS advised that between 7:15 and 7:30 P. M. on 5/2/68, he received two telephone calls from an individual who would not give his identity. 



BOTH DISCLAIMED ANY KNOWLEDGE OF ERIC RAY, AKA EARL. RICHMOND WAS UNABLE TO LOCATE SHELBY JEAN FOR INTERVIEW IN SALTVILLE, VIRGINIA, AREA.

SCT. BALDRIDGE SUBSEQUENTLY STATED HE NEVER DISCUSSED TAMPA TRIP WITH ANYONE BUT WIFE AND DIDN'T KNOW IF ANY TRUTH TO IT. SHELBY JEAN NEVER SAID ANYTHING TO HIM TO INDICATE SHE HAD EVER CORRESPONDED WITH OR MAINTAINED CONTACT WITH ERIC RAY, AKA EARL.
