For the information of the Bureau, referenced telephone call from SAC HANCOCK, Albany, indicated that information from the Textile Marking Machine Company, Syracuse, New York, revealed that only two machines, one located in the Los Angeles area, and the other, bearing Serial No. 30769, owned by the Holly Laundry and Cleaners, 48 Broadway, Chula Vista, California, were likely to have produced a laundry mark similar to that found in the abandoned clothing of unknown subject in instant case.

The Albany Office requested that the Holly Laundry and Cleaners be immediately contacted and the owner interviewed concerning their use of the thermo seal laundry mark, and, further, to obtain a sample of this mark.

Mr. R. J. HALPERTY, Manager, Holly Laundry and Cleaners, 48 Broadway, Chula Vista, California, made available thermo seal machine, Model No. H5J1, bearing Serial No. 30769, and samples of this machine were made by ALMA FORD, operator, who normally operates this machine.

Upon viewing the colored photograph of the clothing abandoned by unknown subject, Mr. HALFERTY advised the code "02B-6" was not similar to the code used at the Holly Laundry and Cleaners.

Mr. HALFERTY also advised, as did Mrs. ALMA FORD, that the color red appearing on the laundry mark in this colored photograph was in no way similar to the tape used at the Holly Laundry and Cleaners. According to them, they have never used this color of red, and the nearest shade is a light pink, upon which were made the sample laundry marks.

Enclosed for the Bureau is a white handkerchief containing samples of Model No. H5J1, Serial No. 30769, in the identical code "02B-6" as are pictured in the colored photographs received from the Bureau. Also contained on this handkerchief are sample laundry marks similar to those used by the Holly Laundry and Cleaners.

The enclosure is being forwarded to the Bureau for comparison with the laundry marks on abandoned clothing. It is not necessary that the Bureau return the enclosure to the San Diego Division and may dispose of it as it so desires.

On 4/9/68, the following investigation was conducted by SA WILLIAM O. HEATON at San Diego, California:

Mr. PARALTO, Manager, Hotel Del Coronado Laundry, 1500 Orange, Coronado, California, telephone number 435-1845, telephonically advised that the Hotel Del Coronado Laundry uses a Thermo Seal marking machine, and that the marking number "02B-6, or D2B-6," was a mark that could have come from their machine. Mr. PARALTO advised that their laundry marking classifications are as follows:

Month, Lot Number, Employee's initials,
Bundle Number.

02B-6, or D2B-6 would be October or December,
Lot Number 2, Employee named Beverly, and Bundle Number 6.

Mr. PARALTO advised that his employees usually use the first initial of their last name, however, Mr. PARALTO advised that he has one employee who uses the first letter of her first name, BEVERLY.

Mr. PARALTO advised that he would check his records for laundry identifiable with 02B-6 or D2B-6.

Mr. PARALTO advised that he was not sure whether his particular Thermo Seal marking machine had 15 pt. letters for O and D and 2 and 18 pt. letters for the B and 6.

Re memo of Security Patrol Clerk JOSEPH L. STATLEY dated April 6, 1968.

The following investigation was conducted by SA ARNOLD W. O'BRIEN:

Mr. DONALD SORBIN, 3949 Alicia Drive, Point Loma, California, advised as follows on 4/8/68:

Mr. SORBIN is employed as a mechanic for the San Diego Gas and Electric (SDGE) Company and is acquainted with an individual named JACK D. ETHERIDGE.

According to SORBIN, ETHERIDGE is formerly from the Memphis, Tennessee, area and is highly prejudiced against the negro race. ETHERIDGE is also a sportsman and does a lot of shooting. SORBIN does not know the extent of firearms owned by ETHERIDGE.

ETHERIDGE is also in financial difficulty as a portion of his wages are being taken out on a weekly basis to pay his debtors. ETHERIDGE is also having trouble with his wife, who is suffering from cancer.

According to SORBIN, ETHERIDGE last worked at the SDGE on Wednesday 4/3/68 from 4:30 p.m. until 1:00 a.m. 4/4/68. ETHERIDGE was supposed to report for work again at 4:30 p.m. 4/4/68 but did not show up for work.

During the evening of 4/4/68 ETHERIDGE's wife called the SDGE inquiring as to the whereabouts of her husband stating that she had not seen him since approximately 11:30 p.m. 4/4/68.

SORBIN advised that he is presently on vacation and was not working Friday, 4/5/68, and has no personal knowledge as to whether ETHERIDGE returned to work on that date; however, from conversations with other employees they state that ETHERIDGE did return to work at 4:30 p.m. 4/5/68.

SORBIN further advised that ETHERIDGE, in his opinion, is the type of person who might commit such an act against Dr. MARTIN LUTHER KING.

Mr. JACK NORRIS, Security Officer, SDGE, made available the following background information on 4/8/68 concerning JACK DOYLE ETHERIDGE:

ETHERIDGE has been employed for the SDGE since June, 1960. He is presently employed as an auto mechanic in their Transportation Department.

ETHERIDGE was born [redacted] at West Memphis, Arkansas. He is 5'10" tall, weighs 170 lbs., blonde hair and blue eyes. His Social Security Number is [redacted]. He is married and his wife is MARY JOANN ETHERIDGE, and they reside at 1265 Azusa, San Diego, California.

ETHERIDGE has previous military service in the U. S. Air Force from January, 1956, to May, 1960. He was an Airman first class and received an honorable discharge.

According to the records of the SDGE ETHERIDGE worked from 4:30 p.m. to 1:00 a.m. on 4/4/68 and was on sick leave on his 4:30 p.m. to 1:00 a.m. shift 4/4/68. The records further indicated that he returned to work at 4:30 p.m. 4/5/68 and worked until 1:00 a.m. 4/6/68.

Credit record check concerning JACK D. ETHERIDGE was negative.

Criminal record check was negative at the San Diego Police Department, however, the records of the San Diego County Sheriff's Office reflect ETHERIDGE, JACK DOYLE on February 27, 1964, purchased a Lugar SuperBlackhawk .44 caliber revolver from TOMMY MOKOAN, 4317 Fillmore Avenue, San Diego, California. At that time ETHERIDGE was residing at 4736 Rennex Place, San Diego, California, and was employed as an auto repairman for SDGE. He was described as follows:

On April 8, 1968, after signing a Waiver of Rights form JACK DOYLE ETHERIDGE, 1265 Azusa Street, San Diego, California, was interviewed by ARNOLD W. O'BRIEN and ALFRED A. REGINATO and he advised as follows:

ETHERIDGE advised that on 4/3/68 he worked at his job at the SDGE from 4:30 p.m. until 1:00 a.m. 4/4/68. He came home a short time after work and stayed at his home until approximately 11:30 a.m. 4/4/68. Because of the fact that he was having difficulties with his wife, he left the house and went to see a girl friend known to him only by the first name JOANNE. According to ETHERIDGE, JOANNE resides at 2711 Figuerora Boulevard, San Diego, California, and is employed as a waitress at Sheldon's Restaurant on the corner of Balboa Avenue and 101 Highway, San Diego, California. ETHERIDGE advised that he spent the entire day at JOANNE's residence and did not return to his residence until approximately 11:30 p.m. 4/4/68. He returned to work at 4:30 p.m. 4/5/68.

ETHERIDGE further advised that he also worked the 4:30 p.m. shift 3/29/68 until 1:00 a.m. 3/30/68.

On 4/10/68 Mr. PARALTO, Manager, Hotel Del Coronado Laundry, 1500 Orange, Coronado, California, was contacted by SA ARNOLD W. O'BRIEN, at which time he made available samples of the laundry mark made from a Thermo-Seal machine used at the Del Coronado Hotel.

It will be noted that the samples made in the identical manner as that found on the Unknown Subject's clothing "02B-6" and D2B-6" were made by this machine.

It will be noted that the "D2" and the "02" characters are of the same size as the "B" character and are dissimilar to the characters "D2" and "02" found on the Unknown Subject's clothing.

It will also be noted that following the "6" is a dash. According to Mr. PARALTO this dash follows the "6" in all instances. It will be noted that this dash does not follow the "6" found on the marking of the Unknown Subject's clothing.

Even though the Del Coronado Hotel uses a similar type code as that found on the laundry mark on the clothing of the Unknown Subject, in view of the differences noted above it is not deemed necessary to submit the sample obtained from the Del Coronado Hotel to the Bureau, but is being retained as a 1A exhibit in this case.





Assassin Is Sought In Mexico

MEMPHIS (UPI) — The assassin of Dr. Martin Luther King Jr. may have fled the country, officials said today. The FBI has asked Mexican authorities to aid in the search.

A policeman in Mexico City said that a drawing of the suspect, a composite of descriptions by persons who saw the white sniper in the Memphis rooming house from where King was shot, has been distributed throughout Mexico and at border crossing points.

The Mexican spokesman refused to divulge any further information.

"There is an investigation going on, that is all we can say," he said.

U. S. Atty. Gen. Ramsey Clark, said yesterday in Washington, the "trail has lengthened" since Friday, the day after King slumped to his death on a motel balcony with a gaping rifle bullet wound in his neck.

The FBI has "one man on the run," Clark said. "We have a name, but whether it is the right name remains to be seen.

"We hope he'll be under arrest quite soon. The focus is sharpening and we are quite close, we think, but that depends on how some of the leads we have develop."

The assassin was described by the landlady who rented him a room the day of the slaying as a man with a sharp nose, square chin, black hair receding on the sides, and "a silly smile." He is about six feet tall and between 26 and 32 years old, witnesses said.

Police said he was cool and quick-acting.

He had less than 24 hours, after he heard and read that King was staying in the Lorraine Motel (King had stayed in another motel on a visit the previous week), to choose a site and make preparations for the assassination.

He chose a flophouse across the street from the Lorraine, apparently not because it offered any better view than several other buildings in the area, but because it was closer.
