

call from RONALD LORENZEN, Managing Editor, Times Democrat, Davenport, Iowa at 9:30 am this date.

Mr LORENZEN advised that he received a telephone call from EDWARD BAUMGARTNER, 917 6th Avenue, Erie, Illinois, 61250 on 4/5/68. He stated that BAUMGARTNER advised him he may have some information regardingthe assassination of MARTIN LUTHER KING, JR. as he was a former Minuteman as he escaped from them at Palo Alto, Calif. and the assassination sounded to him like it might have been done by the Minutemen. LORENZEN stated that he thought hhe caller was a nut, but he received an additional call after the photograph was shown on television at which time BAUMGARTNER stated that the photograph appeared to be one VINCENT DEPALMA of an unknown address in Conn.

LORENZEN requested that he be notified by the FBI of the outcome of the inquiry. He was advised by the writer that we do not make public the results of theinvestigations we conduct. He stated that he would call in a couple of days.
