A photograph of JAMES EARL RAY, FBI #306 443 A, was exhibited to her, however, she advised that she did not know RAY. She advised that she had not seen this individual with her son, WALTER TERRY RIFE, and knew nothing concerning RAY's whereabouts.

On March 25, 1968, VIOLA MAYFIELD, 2716 Cherry Street, advised that she is the sister of WALTER TERRY RIFE and operates VI's Style Salon at that address. She advised that her brother, WALTER RIFE, had been living with another brother, LONNIE RIFE, at Baylis, Illinois. She advised that the photograph of JAMES EARL RAY was unfamiliar to her and that she had, to her knowledge, never seen this individual in her life. She could furnish no information concerning JAMES EARL RAY.

On March 25, 1968, FLOYD RIFE, 226 Lind Street, Quincy, Illinois, advised that he is the brother of WALTER TERRY RIFE. He viewed a photograph of JAMES EARL RAY and stated that he had never seen JAMES EARL RAY to his knowledge. He advised that WALTER RIFE has been operating for several weeks the restaurant located in the Virginia Hotel in Quincy, Illinois, and he, FLOYD, is in that restaurant almost on a daily basis and he had not seen or heard anything concerning JAMES EARL RAY.

On March 25, 1968, Captain HAROLD HUNSAKER, Quincy, Illinois, Police Department, advised that his department has received no information in the recent past concerning JAMES EARL RAY, FBI #306 443 A. He advised that the last record in his file concerning RAY was when RAY was arrested in Hannibal, Missouri, in 1955 with WALTER TERRY RIFE.

On March 25, 1968, DONALD G. OITKER, 321 South 7th Street, Quincy, advised that he has lived at that address for a number of years, and that the name KATHERINE DORIS BUSKIRK is unfamiliar to him. He advised also that he has never heard of an individual named JAMES EARL RAY, and after viewing a photograph of JAMES EARL RAY, FBI #306 443 A, advised that he does not know this individual.

Good Likeness Of Ray FBI Issues Two New Photos Of Assassin Suspect

WASHINGTON (UPI)—The FBI distributed Tuesday two more photographs of the accused killer of Dr. Martin Luther King—one of them extremely good likeness.

Both were snapshots of James Earl Ray, alias Eric Starvo Galt, an escaped convict accused of shooting King to death in Memphis April 4.

The "extremely good likeness" is a candid photograph of Ray in a business suit and tie and shows almost his full face, taken in late January or early February somewhere in California.

The other, which the FBI said was taken last November somewhere in Mexico, shows him wearing sun glasses and what appears to be a white sports shirt. The FBI said Ray is known to wear sun glasses frequently.

The two new photographs the FBI refused to say where or how they were obtained will be displayed throughout the country along with three other pictures of Ray which now appear on FBI's wanted posters.

One of the earlier photographs was taken when Ray was graduated from bartending school in Los Angeles early this year. His eyes were closed

when the shutter snapped, but they were sketched in by the FBI artist. The picture shows him wearing a white shirt and a black bow tie.

The other two photographs were made when Ray entered the Missouri State Prison in 1960 to serve a 20-year sentence for armed robbery.

Ray, who escaped from prison April 23, 1967, by hiding in a truck, is wanted by the FBI for illegal flight to avoid prosecution in Tennessee for King's murder.

The civil rights leader was shot to death on a motel balcony, apparently by a gunman 200 feet away in a roominghouse bathroom.

Thirteen days later the FBI announced it had issued a warrant for Galt, but after checking some 53,000 fingerprints, the FBI said two days afterwards that Galt and Ray were the same man.

Ray was added to the FBI's list of 10 most wanted criminals April 20. There have been reports of the search extending to various foreign countries, including Australia, and authorities along the U.S. borders have been alerted to watch for him.
