NO WAY IDENTIFY RAY FROM TWO RECENT PHOTOS. STEWART FURTHER STATED THE PHOTO OF RAY WITH EYES CLOSED WHICH IS SIMILIAR TO THE PHOTO IN WANTED FLYER WITH EYES DRAWN BY ARTIST IN NO WAY RESEMBLED PERSON HE SAW.

REVEREND STEWART MENTIONED THE SUPERVISOR WAS NORMAN GADDIS WHO PORTRAYS HIMSELF AS AN AMATEUR ARTIST. GADDIS FAILED TO POSITIVELY IDENTIFY RAY IN CONTACT WITH GADDIS ON MAY TWENTYNINE AND THIRTY FIRST SIXTYEIGHT. HE MENTIONED INDIVIDUAL NOT DRUNK HOWEVER HE COULD NOT FURNISH POSITIVE INFORMATION MAINTAINING HE ONLY NOTED THE EYES WHICH WERE DISTINCTIVE AS IN THE WANTED FLYER OF RAY BUT DIFFERED FROM THE EYES OF THE INDIVIDUAL HE HAD SEEN. GADDIS COULD NOT IDENTIFY THE TWO RECENT PHOTOS OF RAY SHOWN TO HIM ALONG WITH OTHER PHOTOS.

SA RAYMOND F. BERNEKING, Decatur RA, on 5/31/68 telephonically alerted office to possible press inquiry re JAMES EARL RAY, who is widely sought as a fugitive in above case. BERNEKING advised that on Tuesday night, 5/28/68, a Presbyterian Church at Decatur, Ill., held a street dance for the underprivileged children, mainly Negroes, in the Decatur area. According to Information furnished him by Rev. GORDON C. STEWART, Assistant Pastor of the church, an unknown individual driving past the street dance stopped his car, left the lights on and walked over to observe the social function. He spoke to a few of the adults in attendance, observing that they were doing a wonderful thing in conducting the social activity for the Negro children. Rev. STEWART, curious as to his identity, asked the individual his name, and he was told it was "STEVERINO". The unknown individual was also observed by another individual other than Rev. STEWART, although neither could get a good look at him because it was 10 PM at night, dark, and the individual stood in the shadow cast by a tree between him and a dark blue street light, of the flouriscent type.

This matter was immediately reported to the Decatur Office but on Wednesday, the Rev. STEWART contacted SA BERNEKING and stated he and his associates had talked over the stranger who had visited the street dance and had decided he bore some faint resemblance to published photographs of JAMES EARL RAY. Reverent STEWART observed several photographs in the Decatur RA made of JAMES EARL RAY at various stages in his career but could not identify him by face outline or hairline and only found that the individual seen by him had eyes which resembled the eyes drawn on RAY's bartender photograph by a Bureau artist. Rev. STEWART gave SA BERNEKING the name of one of the individuals who had the most contact with the unknown man, and SA BERNEKING was able to contact this individual telephonically on Wednesday night but could not arrange for an interview with him prior to Friday, 5/31/68, because the individual had other commitments.

SA BERNEKING stated he was confident from his interview personally of Rev. STEWART and telephonically with the other

individual that our fugitive was not in Decatur. However a member of Rev. STEWART's church is a reporter for the local Decatur newspaper, is aware of the information furnished by STEWART to the FBI, and has made inquiries as to whether or not RAY was in town. SA BERNEKING has contacted the editor of the Decatur Herald, explaining this matter to him indicating that it appears to be merely one of numerous investigative leads which we receive in this case from well-meaning individuals, which result in a blind alley. The editor observed to SA BERNEKING that the activities of the unknown individual were such as to make it highly questionable that he was, in fact, JAMES EARL RAY, and he saw no news value in this matter.

Subsequently, the office at Springfield was contacted by JOHN KANGILASKI, a reporter on the Chicago Daily News, Area Code 312 321-2121, which is the extension of the City Desk. KANGILASKI, who advised he was formerly in Cincinnati where he was acquainted with former SAC ED MASON, advised two Associated Press (AP) urgent releases had been made from Decatur to the effect that a minister and another individual had viewed photographs of a person who appeared at a street dance Tuesday night and felt the individual resembled RAY. He wondered if there was any substance to this and was advised we could not comment on that matter. He was thanked for his interest, however, and it was explained in general terms the manner in which Wanted Flyers and Identification Orders result in calls being made to Bureau offices on look-a-likes and persons bearing some resemblance. He advised he was well aware of this from prior contacts with the Bureau, and understood our position completely. Mr. KANGILASKI advised that according to the AP wire releases, allegedly several residents of Decatur have told authorities that they saw the man who resembled pictures of RAY on Tuesday night.

SA BERNEKING again contacted and advised AP representative had also contacted the Decatur PD, which had refused to comment on this matter. SA BERNEKING stated he was in the process of interviewing the second individual who saw the man; and in view of this circumstance, more additional current photographs of RAY have been dispatched to SA BERNEKING to help in eliminating the individual.
