SA SPURGEON J. PETERSON determined from MR. T. E. UMPHRES, Area Security Supervisor, SOUTHWESTERN BELL TELEPHONE CO., SLMO, (PROTECT), that ME 1-7777 is issued to RAY BEZDEK doing business as RAY's SPORTING GOODS, 284 Lemay Ferry, SLMO.

On 6-7-68, RAY BEZDEK, 284 Lemay Ferry, SLMO, advised SA JOSEPH A. DUBJAK that he was unable to recognize the photo of subject as being anyone known to him and that the names JAMES EARL RAY, and aliases used by subject, were likewise unfamiliar to him.
