THE PSYCHIATRIST WAS OF THE OPINION THAT CONSIDERABLE LENIENCY WAS DESIRABLE IN DEALING WITH WILSON SINCE ORIGIN OF TROUBLE BEGAN WITH BATTLE-INCURRED WOUND. IT WAS THEN RECOMMENDED THAT HE BE SEPARATED FROM THE MILITARY BECAUSE OF UNSUITABILITY.
