After leaving Clarence, he went alone to St. Louis where he had various employments. He was employed as a service station attendant for the Site Gasoline Station on Lemay Ferry Road.

He stated he owned an old store building with sleeping rooms upstairs, that he rented, operated a second hand store, and a dry cleaning store.

He sold this property in St. Louis and bought the small acreage at Center, Missouri, last September (1967). He added he is drawing social security and is retired.

He stated that he does not approve of subject's actions, is afraid of him, and what the publicity is doing to his daughter, CAROL, and her family. He stated that if he should hear anything about the subject's whereabouts he will advise the Federal Bureau of Investigation.

JERRY RAYNES advised that he is the stepfather of JAMES EARL RAY as JAMES EARL RAY was born in [redacted] at Alton, Illinois, and Mr. RAYNES stated he married LUCILLE MAHER at Jacksonville, Florida, in the spring of 1929, 1930 or 1931. He believes he was 30 years of age at that time and that she was 23 years of age. Following their marriage, they lived in Quincy and Galesburg, Illinois, and in St. Louis and Ewing, Missouri. It was his understanding that LUCILLE was born in Bridgeton, New Jersey.

Mr. RAYNES stated he believes he was the father of all of the other children born to LUCILLE MAHER and himself. Their son, JERRY, was born in Quincy, Illinois, date unknown, under the name JERRY RAYNES. Several of the other children were born in Ewing, Missouri. His daughter, CAROL, was born there on [redacted]

Mr. RAYNES stated he had received a telephone call from his son, JERRY, in Chicago, Illinois, on April 19, 1968, advising him that it appeared JAMES EARL RAY was involved in the KING assassination.

Mr. JERRY RAYNES, Route 2, Center, Missouri, was contacted at his residence. Both interviewing agents identified themselves to him by exhibition of their credentials and he was advised by SA DUFFEY that they desired to interview him concerning JAMES EARL RAY, who was believed to be his son. He was told of the seriousness of the investigation and of the provisions of the harboring statute by SA DUFFEY.

Mr. RAYNES stated he would willingly cooperate and conducted the agents through the bedroom and into the kitchen in order that they might see no one else was at the home.

Mr. RAYNES stated he is 69 years of age having been born [redacted]. He was married to one LUCILLE MAHER, now deceased. Eight children were born to this marriage. Mr. RAYNES stated that his memory was somewhat fuzzy and that he experienced difficulty in recalling specific events. He stated that he doubted that all the children were his but was of the opinion that JAMES EARL, who had been born in Alton, Illinois, in 1928, was his own child. He stated he knew nothing whatever of JOHN. One son, FRANKLIN, also known as 'BUZZY' or 'BUZZ', was killed in an accident at Quincy, Illinois, in about 1958. He has another son, JERRY, who is currently living in Chicago, Illinois. He has a daughter, CAROL PEPPER, who lives on Belleview Avenue in Maplewood, Missouri, and another daughter, MELBA RAY, whom he believed currently resides in Quincy, Illinois. He stated that MELBA was a mental case who had received treatment in the Illinois State Hospital at Jacksonville, Illinois. He recalled that there were two other children, [redacted] and SUSIE, who were given away by their mother after his separation from her. Their current whereabouts are unknown to him.

Mr. RAYNES stated he had little contact with his children during the past 17 years, except for CAROL. To the best of his recollection he last saw JAMES EARL RAY, 17 years ago and has had no direct contact with him since. He was aware that subject had been in the penitentiary from news items and from information he had received from the children's mother, LUCILLE. He stated that she had become an alcoholic

when the family resided in Ewing, Missouri, and later in Quincy, Illinois. They separated at Quincy, but he was unable to recall the year.

Mr. RAYNES stated he has always used the name of RAYNES but he knew that some of the children had shortened the name to RAY. He was aware that subject had used several aliases.

Mr. RAYNES stated he knew nothing concerning subject's implication in this case until he received a telephone call from his daughter, CAROL in which she stated that the FBI had contacted her concerning subject. He stated he had received two telephone calls that evening, one from CAROL, and the other from MELBA, each stating the news items indicated their brother, JAMES was involved in the KING murder. He stated he did not know how MELBA learned of his whereabouts as he had not seen her or heard from her for the past seven or eight years. She had indicated she was calling from Quincy, Illinois.

Mr. RAYNES stated that he had no knowledge or information as to subject's whereabouts. He stated he was afraid of subject and was concerned that subject might attempt to contact him. He stated he wanted no part of the subject and that he had consequently barred his doors. Mr. RAYNES stated that he would gladly cooperate with the FBI and would immediately bring to the attention of its agents any information he received concerning subject or his whereabouts.

BOBBY JAMES, Wardell, Missouri, advised upon interview that he is approximately the same age as J.D. DAILEY and recalled J.D. and other members of the family working intermittently on farm land operated by his father from the time they were small children until they became grown. He also worked for several years for the Acom Cotton Gin at Wardell, Missouri, where J.D. DAILEY's father, BARNEY DAILEY, worked for a number of years until he passed away a few years ago.

JAMES stated that J.D. DAILEY married one of the GASKIN girls of WARDELL and that her brother, HARLEY B. GASKIN still resides in the Wardell area. Another brother, CLEO GASKIN reportedly resides somewhere in St. Louis. A brother-in-law of J.D. DAILEY, one EWELL DE PRIEST, presently resides north of Wardell on Highway B. A sister-in-law, Mrs. STANLEY (ELIZABETH) BLURTON, is also believed to still be residing in the Wardell, Missouri, area.

According to BOBBY JAMES he has never heard of any members of the DAILEY family, the GASKIN family, the DE PRIEST or the BLURTON family being land owners in the Wardell, Missouri, area.

WO. JAMES, residing approximately two miles south of Wardell, Missouri, on County Highway B, advised upon interview that he has known the family of J.D. DAILEY since the time J.D. DAILEY was approximately five years of age. At about this time DAILEY's father, BARNEY DAILEY and the other members of his family began working as cotton choppers and cotton pickers on land farmed by Mr. JAMES in the vicinity of Wardell, Missouri. This type of irregular employment by the members of the BARNEY DAILEY family continued intermittently until the time J.D. DAILEY quit high school and drifted out of the Wardell area. On various other occasions subsequent to this time, J.D. DAILEY would return to the Wardell area and work for a short period of time on land operated by JAMES.

According to JAMES neither BARNEY DAILEY who is deceased or any of his children have ever owned or even sharecropped any land in the Wardell area to his knowledge. During the last several years of his life, BARNEY DAILEY operated a gin at Wardell, Missouri. He recalled that J.D. DAILEY was always considered a trouble maker and was always in some difficulty with the law in the local area and he heard that he was in similar trouble in the St. Louis area after he left Wardell.

Mr. JAMES furnished the name of other members of the DAILEY family as being HAZEL RANDELL TERRELL, presently residing a couple of miles north of Wardell; ADA JILES and LILLIAN DAILEY present addresses unknown.

He advised that BARNEY DAILEY was an individual who drank to excess when he was not working and the three daughters named above were generally considered in the community as being women of loose morals.

JAMES stated he was positive that J.D. DAILEY never owned, operated or sharecropped a farm in the area of Wardell and he knew of no individuals residing on farms in the general area who were close friends of DAILEY.

JAMES A. SELLERS, who resides on County Highway B, one mile north of State Route 84 in Pemiscot County, Missouri, advised he is chairman of the Pascola Township Agriculture Stabilization Committee of Pemiscot County, Missouri. In this capacity he had in his possession a Pemiscot County map reflecting the various townships of Pemiscot County with the names of the land owners written in on the land plots of the various farms within the townships of that county.

The maps of Pascola Township covering the area surrounding Pascola, Missouri; the Little River Township covering the Wardell, Missouri, area; and the Peach Orchard Township covering the Bragg City area were examined.

There were no farm owners by the name of DAILEY listed in any of the three above-named townships.

Mr. SELLERS advised he is 95 percent familiar with all of the land owners in the Pemiscot County area west of U.S. Highway 61 and north of State Highway 84 and there is no land owner by the name of DAILEY operating in that area.

He went on to state that in his capacity of township committee chairman, he is also familiar with tenants and sharecroppers in this area and he has never heard the name DAILEY mentioned in this capacity.

Mrs. HAZEL TERRELL, Wardell, Missouri, advised that she is the sister of J. D. DAILY who currently owns and operates a restaurant that he recently purchased in Portageville, Missouri.

Mrs. TERRELL pointed out that in addition to J. D. DAILY being her brother she has two other sisters; namely, ADA GILES who formerly resided at 1812 North Washington Street, Chicago, Illinois, but who recently moved and can be contacted through her daughter, VITA NEWTON, telephone number 421-2853 in Chicago, Illinois. Another sister LILLIAN JOHNSON resides at 2012 Sidney Street, St. Louis, Missouri. She pointed out that both parents are deceased.

She stated that their father, BARNEY DAILY was a ginner for a Mr. ACON's cotton gin, Wardell, Missouri, and they never resides on or owned a farm. She stated that she has never known her brother, J. D. DAILY, to own, operate or lease a farm noting that most of his life has been spent in a tavern business in St. Louis, Missouri.

Mrs. TERRELL pointed out that she has never heard her brother speak of JAMES EARL RAY and she has never heard him mention any persons acquainted with anyone allegedly connected with the Doctor KING assassination.

Mrs. TERRELL pointed out that in event she should learn that J. D. DAILY has any personal knowledge of JAMES EARL RAY she would immediately contact the FBI.

She also noted that she knew of no close friends or associates of J. D. DAILY's who lived on a farm or owned a farm in this area.

SHELBY TERRELL, Wardell, Missouri, advised that he is the brother-in-law of J. D. DAILY being married to J. D.'s sister HAZEL.

He stated that he has known J. D. DAILY since 1946, although he has not closely associated with him because until about a month ago J. D. DAILY operated a tavern in the St. Louis area and only infrequently visited in Wardell, Missouri.

Mr. TERRELL stated that J. D. DAILY now operates a restaurant in Portageville, Missouri, and lives in that town having recently purchased this restaurant.

He stated that he has never known J. D. DAILY to own, operate, lease, rent or visit for any length of time on a farm nor does he know of any of J. D.'s close friends who own farms.

Mr. TERRELL stated that he has never heard DAILY mention JAMES EARL RAY nor has he talked about the assassination of Doctor KING. Mr. TERRELL noted that he has seen J. D. DAILY more frequently in the past month since DAILY owns a restaurant in Portageville than he has in the past fifteen years.

Mr. TERRELL noted that J. D. DAILY had three sisters; namely, HAZEL (SHELBY TERRELL's wife), ADA GILES of Chicago, Illinois, and LILLIAN JOHNSON of St. Louis, Missouri.

Mr. TERRELL noted that in the event he hears any information at all that would indicate that J. D. DAILY had any contact with or any personal knowledge of JAMES EARL RAY he would immediately notify the FBI.

On 5-1-68, SA's FRANK E. CORN, SR., and ROBERT C. HAINES, interviewed HILLIARD ALLEN SANDERS, at 137 East Acton Street, Wood River, Illinois.

SANDERS stated that he was incarcerated in the Missouri State Penitentiary, Jefferson City, Missouri, on 1-20-52, upon conviction of an armed robbery charge at St. Joseph, Missouri. He said he was released on parole on 9-1-64.

SANDERS advised that he never became acquainted with or had knowledge of JAMES EARL RAY during the time he was incarcerated in the Missouri State Penitentiary. He said that while he was in the penitentiary, he worked at several trades and that the last two jobs he had in the penitentiary had to do with the sewing machine mechanical section and that the last job he had was a halltender from 1963 to 1964.

SANDERS said that upon parole he went to Gadsden, Alabama, where he lived and worked for approximately 18 months; that he then went to Camden, South Carolina, where he was employed by the firm of E. I. DUPONT for 9 months. SANDERS said that he then came to Wood River, Illinois, where he has been working on construction at the Shell Oil Company Plant in Wood River. He said that he arrived in Wood River in 7-67 and has resided in Wood River since that time.

SANDERS concluded by stating that when national publicity was released concerning the identification of JAMES EARL RAY, he viewed photographs appearing on television and in the news media and determined that he had never known RAY while both were at the Missouri State Penitentiary.

HE WAS ADVISED BUREAU WOULD PROBABLY NOT PRESUME TO ADVISE HIM AS TO PROPRIETY OF POSTPONEMENT, OR OTHER ACTION IN MATTER, AS SAME ENTIRELY WITHIN HIS OWN DISCRETION, BUT AT HIS INSISTENCE IT WAS AGREED THAT MATTER WOULD BE BROUGHT TO BUREAU ATTENTION FOR WHATEVER OBSERVATIONS IT MIGHT CARE TO MAKE.
