
On 5/28/74, at 2:45 p.m., DAVID J. GAINES, 6171 Leesburg Pike, Apt 532, Falls Church, Virginia, telephone number 534-5572, visited WFO and stated that he would like to remit the enclosed tape recording for consideration.

GAINES stated that the tape contains a converstaion between his wife, SHIRLEY GAINES, and an individual who identifies himself as BILL (MNU) HARRIS. Both participants on the tape were in a semi-inebriated state when the recording was made. In the recording, HARRIS states that JAMES EARL RAY had nothing to do with the assination, but that he and others conected with the United Auto Workers and the Teamsters Unions planned and paid for the assination.

The recording was made while GAINES was on a job as a private court and conference recorder at a Public Hearing on Cheasapeake and Ohio Canal Citizen Advisory Commisssion at Brunswick, Maryland, sometime in June of 1972. During the job, he and his wife were staying at the Hawiian Hotel in Brunswick. HARRIS and several other men were staying in the room next to theirs.

SHIRLEY GAINES heard on the radio last week that several men were being investigated for their part in the assination of Dr. KING. She then remembered the



He applied for the apartment, paid for a month's rental of \$240. Which turned out to be a bum check. It was dated 4/1/68 and signed by a G. M. NOVEL, drawn on the Citizens National Bank & Trust of Columbus, Ohio. This individual never did occupy the apt., since Mrs. DuBois learned that the check was no good before he had a chance to move in.

Mr. DuBois said that his wife feels; that the man she was negotiating with for the rental was in fact captioned subject as he strongly resembeled photographs of the subject which were prominently in the papers at that time.

KING arrived in Memphis on the morning of 3/28/68, from Atlanta, Georgia. The sanitation workers at Memphis were then on strike in what had become a long, bitter dispute over wages, check-offs, etc. The sanitation workers were represented by the American Federation of State, County and Municipal Employees (AFSCME) of which one JERRY WORTH was President. WORTH had been in Memphis during part of this strike, but this office cannot say whether or not WORTH was here on any particular day. HENRY LOEB was then the Mayor of Memphis.

KING led a march through downtown Memphis shortly before noon on 3/28/68, but the march had barely gotten underway before the marchers began looting the stores along the route of the march. KING fled the scene, and the Memphis Police Department dispersed the mob and forced them out of the downtown area.

KING spent the night of 3/28/68, in Memphis, leaving the next day to return to Atlanta. KING's prestige had suffered a serious blow in that he had been unable to control his followers and the "peaceful" march had turned into a riot. It has been speculated that KING's return to Memphis on 4/3/68 was done at the urging of his advisors, and his leading another march on 4/5/68, was to be done to rebuild his public image. As you are aware, KING was shot and killed at about 6:00 pm on 4/4/68, while standing on the balcony of his motel.

All of the evidence in this case points to the fact that JAMES EARL RAY, acting alone, was KING's murderer. There has been nothing to indicate that RAY ever received any large sum of money from anyone, and what we know of his living habits, both before and after the murder, would indicate he lived on a very limited amount of money. We const know the source of even the small amount of money possessed by RAY, but since we know him to have robbed a bank in

ME 44-1987

England after fleeing to that country, it is a reasonable presumption that RAY committed robberies in the United States during the time he was a fugitive.

RAY entered a plea of guilty to the charge that he murdered KING and is now serving 99 years in the Tennessee State Prison. At the time of his guilty plea RAY was represented by PERCY FOREMAN of Houston, Texas. RAY now claims he was not adequately represented by FOREMAN, and he is attempting to have his guilty plea set aside in order to be granted a trial in state court.

RAY's current attorneys have made public statements to the effect that RAY bought the murder weapon and brought it to Memphis thinking he was part of a gun smuggling operation. They claim he did not know the gun was to be used to murder KING, and they claim that RAY did not pull the trigger. AIRTEL

# Ray Appeals Conviction in King Murder

Associated Press

James Earl Ray, convicted killer of civil rights leader Dr. Martin Luther King Jr., asked the Supreme Court yesterday to review his case. claiming he was "set up to take the rap for a crime he didn't commit."

Ray's appeal said he was "framed by the FBI and local police, and then coerced by his own attorney to plead guilty against his will."

James H. Lesar, the Washington attorney representing Ray, wrote in asking the court to review Ray's conviction: "The charge is that those who did kill Dr. King are still at large, protected in part by the unwillingness of the courts to face these unpleasant facts.

The petition did not mention an investigation recently begun by the House into the assassinations of King and President Kennedy.

King was killed by a rifle blast as he stood on a motel balcony in Memphis in 1968.

Ray was arrested in London and brought back to the United States to stand trial. He pleaded guilty.

In his petition, Ray, now an inmate serving a life term in the Tennessee state penitentiary, said a thorough review of his conviction is needed because potential conflicts of interest between two of his attorneys denied him "effective assistance of counsel." Ray was represented originally by attorneys Arthur Hanes and Percy Foreman.

Marler continued to cry and doze off as he related the above facts and when asked why he had not come to the FBI earlier, he explained that he did not wish to make a complaint at that time because it would disgrace his family.

Marler, in conversation, admitted being an alcoholic and under the influence of drugs for which he has a doctor's prescription. In addition, he currently is an outpatient in the Veteran's Administration Hospital for mental incompetency.


