On 5/28/74, at 2:45 p.m., DAVID J. GAINES, 6171 Leesburg Pike, Apt 532, Falls Church, Virginia, telephone number 534-5572, visited WFO and stated that he would like to remit the enclosed tape recording for consideration.

GAINES stated that the tape contains a conversation between his wife, SHIRLEY GAINES, and an individual who identifies himself as BILL (MNU) HARRIS. Both participants on the tape were in a semi-inebriated state when the recording was made. In the recording, HARRIS states that JAMES EARL RAY had nothing to do with the assassination, but that he and others connected with the United Auto Workers and the Teamsters Unions planned and paid for the assassination.

The recording was made while GAINES was on a job as a private court and conference recorder at a Public Hearing on Chesapeake and Ohio Canal Citizen Advisory Commission at Brunswick, Maryland, sometime in June of 1972. During the job, he and his wife were staying at the Hawaiian Hotel in Brunswick. HARRIS and several other men were staying in the room next to theirs.

SHIRLEY GAINES heard on the radio last week that several men were being investigated for their part in the assassination of Dr. KING. She then remembered the

GAINES stated that the tape contains a conversation between his wife, SHIRLEY GAINES, and an individual who identifies himself as BILL (MNU) HARRIS. According to GAINES, both participants on the tape were in a seminebriated condition when the recording was made. In the recording, HARRIS states that JAMES EARL RAY had nothing to do with the assassination of KING but that he and others connected with the United Auto Workers and the Teamsters Union planned and paid for the assassination.

The record reportedly was made while GAINES was on a job as a private court and conference reporter at a public hearing on Chesapeake and Ohio Canal Citizen Advisory Commission at Brunswick, Maryland, sometime in June of 1972. He stated that during this time he and his wife were staying at the Hawaiian Hotel in Brunswick, Maryland. HARRIS and several other men were staying in the room next to theirs.

GAINES stated that his wife, SHIRLEY, heard on the radio recently that several men were being investigated for their part in the assassination of KING. She then remembered the tape that she and HARRIS had made. GAINES stated that after listening to the tape he decided to bring it to the FBI.

No. 546-9007, telephonically advised that during 1968, at a time when he was overseas, and his wife was in Washington, she was negotiating with an individual for rental of an apartment at 616 A St., NE in WDC. He applied for the apartment, paid for a month's rental of \$240. which turned out to be a bum check. It was dated 4/1/68 and signed by a G. M. NOVEL, drawn on the Citizens National Bank & Trust of Columbus, Ohio. This individual never did occupy the apt., since Mrs. DuBois learned that the check was no good before he had a chance to move in.

Mr. DuBois said that his wife feels ;that the man she was negotiating with for the rental was in fact captioned subject as he strongly resembled photographs of the subject which were prominently in the papers at that time.

KING arrived in Memphis on the morning of 3/28/68, from Atlanta, Georgia. The sanitation workers at Memphis were then on strike in what had become a long, bitter dispute over wages, check-offs, etc. The sanitation workers were represented by the American Federation of State, County and Municipal Employees (AFSCME) of which one JERRY WORTH was President. WORTH had been in Memphis during part of this strike, but this office cannot say whether or not WORTH was here on any particular day. HENRY LOEB was then the Mayor of Memphis.

KING led a march through downtown Memphis shortly before noon on 3/28/68, but the march had barely gotten underway before the marchers began looting the stores along the route of the march. KING fled the scene, and the Memphis Police Department dispersed the mob and forced them out of the downtown area.

KING spent the night of 3/28/68, in Memphis, leaving the next day to return to Atlanta. KING's prestige had suffered a serious blow in that he had been unable to control his followers and the "peaceful" march had turned into a riot. It has been speculated that KING's return to Memphis on 4/3/68 was done at the urging of his advisors, and his leading another march on 4/5/68, was to be done to rebuild his public image. As you are aware, KING was shot and killed at about 6:00 pm on 4/4/68, while standing on the balcony of his motel.

All of the evidence in this case points to the fact that JAMES EARL RAY, acting alone, was KING's murderer. There has been nothing to indicate that RAY ever received any large sum of money from anyone, and what we know of his living habits, both before and after the murder, would indicate he lived on a very limited amount of money. We do not know the source of even the small amount of money possessed by RAY, but since we know him to have robbed a bank in

ME 44-1987

England after fleeing to that country, it is a reasonable presumption that RAY committed robberies in the United States during the time he was a fugitive.

RAY entered a plea of guilty to the charge that he murdered KING and is now serving 99 years in the Tennessee State Prison. At the time of his guilty plea RAY was represented by PERCY FOREMAN of Houston, Texas. RAY now claims he was not adequately represented by FOREMAN, and he is attempting to have his guilty plea set aside in order to be granted a trial in state court.

RAY's current attorneys have made public statements to the effect that RAY bought the murder weapon and brought it to Memphis thinking he was part of a gun smuggling operation. They claim he did not know the gun was to be used to murder KING, and they claim that RAY did not pull the trigger.

GAINES, or SHIRLEY GAINES. Mrs. BITTNER did advise that sometime during 1972, the motel changed hands and felt that because of this,

Mrs. BITTNER further advised that the cards that were reviewed would comprise all the registration cards for those years.

On 8/1/74, Mrs. BETTY FITEZ, Brunswick Police Department, Brunswick, Maryland, advised SA THURSTON that neither BILL HARRIS, DAVID J. GAINES, nor SHIRLEY GAINES are known to her and that none of them have any criminal arrest record with the Brunswick, Maryland, Police Department.

On 8/8/74, TERESA MAIN, Records Clerk, Maryland State Police, Frederick, Maryland, advised SA THURSTON that there is no criminal arrest record under the name of BILL or WILLIAM HARRIS with the State Police Barracks in Frederick, Maryland.

On 8/19/74, Mr. DONALD DARR, Town Clerk, Brunswick, Maryland, advised that he recalls that a Chesapeake and Ohio Canal Citizen Advisory Commission hearing was held at Brunswick during either June or July, 1972, but stated he could provide no information as to whether a SHIRLEY GAINES was employed as a private court and conference reporter at the Brunswick hearing.

On 8/26/74, Mr. JAMES SEWELL, Land Acquisition Officer, Chesapeake and Ohio Canal National Historic Park, National Park Service, Fort Detrick, Frederick, Maryland, advised SA THURSTON that he recalls that during 1972, a series of meetings dealing with the Chesapeake and Ohio Canal Advisory Commission were held between Washington, D.C., and Cumberland, Maryland, and recalls that one of these meetings was held in Brunswick during either June or July, 1972, although he stated he did not attend the Brunswick meeting. He also stated that a JOHN PARSONS, Chesapeake and Ohio Park Planner, 1100 Ohio Drive, S.W., Washington, D.C., (telephone number 202-426-7705), would have attended all of the meetings and could possibly provide information as to whether SHIRLEY GAINES was employed as a private court and conference reporter at the Brunswick hearing. He stated that SHIRLEY GAINES is not known to him.

Baltimore indices were negative pertaining to BILL HARRIS, DAVID J. GAINES, SHIRLEY GAINES, and JERRY WORTH.

Mr. PARSONS advised the hearings were recorded by a court reporter whose identity he does not recall but which can be determined through Hoover Reporting Company. He recalls the reporter, a male, was driven back to his motel after the meeting by PARSONS. The motel was located next to the Hawaiian Restaurant in Brunswick. This reporter, who performs considerable work for the National Park Service, relies heavily upon tape recorders in his work.

Ray Appeals Conviction in King Murder

Associated Press

James Earl Ray, convicted killer of civil rights leader Dr. Martin Luther King Jr., asked the Supreme Court yesterday to review his case, claiming he was "set up to take the rap for a crime he didn't commit."

Ray's appeal said he was "framed by the FBI and local police, and then coerced by his own attorney to plead guilty against his will."

James H. Lesar, the Washington attorney representing Ray, wrote in asking the court to review Ray's conviction: "The charge is that those who did kill Dr. King are still at large, protected in part by the unwillingness of the courts to face these unpleasant facts."

The petition did not mention an investigation recently begun by the House into the assassinations of King and President Kennedy.

King was killed by a rifle blast as he stood on a motel balcony in Memphis in 1968.

Ray was arrested in London and brought back to the United States to stand trial. He pleaded guilty.

In his petition, Ray, now an inmate serving a life term in the Tennessee state penitentiary, said a thorough review of his conviction is needed because potential conflicts of interest between two of his attorneys denied him "effective assistance of counsel." Ray was represented originally by attorneys Arthur Hanes and Percy Foreman.

After a great deal of difficulty keeping Marler on matters relevant to his complaint, Marler continued that he was then put in a cell and after being locked up in a "drunk tank" he was then visited by unknown officers who kicked him, splitting his forehead open and then "hammered" his teeth out.

Marler continued to cry and doze off as he related the above facts and when asked why he had not come to the FBI earlier, he explained that he did not wish to make a complaint at that time because it would disgrace his family.

Marler, in conversation, admitted being an alcoholic and under the influence of drugs for which he has a doctor's prescription. In addition, he currently is an outpatient in the Veteran's Administration Hospital for mental incompetency.
